## Labor's Budget delivers for the Illawarra

Illawarra families and businesses will directly benefit from the Albanese Government's 2023-24 Budget, as this Budget delivers a stronger foundation for a better future.

The 2023 Budget delivers on Labor's promises, provides cost of living relief for our community and named Wollongong as being at the centre of our plan to become a renewable energy superpower.

#### LABOR IS DELIVERING:

- A new Energy Price Relief Plan with a \$500 energy rebate for eligible households and a \$650 rebate for eligible small businesses.
- The largest increase to the bulk billing incentive ever, which will make seeing a doctor cheaper and easier.

- A 15 per cent increase in award wages, for more than 250,000 aged care workers.
- A \$4 billion investment to realise our future as a renewable energy superpower.
- Cheaper child care for around 5700 families in Cunningham from 1 July.
- Cheaper and more accessible medicines.
- An expansion of paid parental leave.
- \$400 million for a further 300,000 Fee Free TAFE and VET places in high skill needs areas from 2024.
- Getting wages moving again.

The Albanese Labor Government's positive plan will grow the economy, support and create jobs, boost renewable energy, improve standards of care for those who need it and invest in education, skills and training.


The budget also brings the Government's total investment to make Australia a renewable energy superpower to more than \$40 billion since the 2022 election.

### **Investing in jobs & skills**

I am delivering on my election commitment to build our skills and capabilities to take advantage of Australia's transition to a clean renewable energy future.

We are investing \$10 million in the state-of-the-art Energy Futures Skills Centre at the University of Wollongong.

The Energy Futures Skills Centre will help build the energy workforce of the future, using modern teaching laboratories and upgraded equipment



to provide real world examples of clean energy technology for teaching and research.

This investment will deliver teaching programs to train and upskill workers for a career in clean energy and clean manufacturing.

The Government is also investing \$2.5 million to upgrade equipment and teaching aids at Wollongong TAFE, creating a Renewable Energy Training facility.

This investment sets up the Illawarra to be a leader in the energy transformation of the coming years and decades.

## Cost of living relief



Increases in the cost-ofliving mean that

household budgets are under pressure. The centrepiece of the Albanese Labor Government's second Budget is a \$14.6 billion cost-of-living package that will help to ease pressure on households while putting downward pressure on inflation.

This includes a \$500 energy rebate for eligible households and a \$650 rebate for eligible small businesses, and access to cheaper medicines.

The Budget delivers more than \$1.6 billion for energy saving upgrades for homes, businesses and social housing.

This investment will help people with older homes and appliances that don't meet modern energy standards to upgrade and help save money.

### **Boost to bulk billing**

Labor is making a historic investment in our health system by delivering the largest increase to the bulk billing incentive ever. This will provide an immediate benefit to over 156,000 Illawarra residents, including children, pensioners and other concession card holders.



This investment will help take pressure off our public hospitals and emergency departments, which are still feeling the strain of a once in a century pandemic.

#### **DELIVERING CHEAPER MEDICINES**

For millions of Australians this budget will see the cost of medicines cut in half with changes to the dispensing of more than 300 PBS medicines for chronic conditions.

It is estimated that this change will benefit more than 85,000 people in the Illawarra who will be able to get more of the medicine they need for less money and less hassle.

### Save energy, save on bills



Labor is boosting electrification and supporting households and businesses access energy upgrades to improve their energy use and save on their energy costs with:

✓ \$1.3 billion to establish the Household Energy Upgrades Fund to upgrade homes with battery-ready solar PV, modern appliances and other improvements to keep them warmer in winter and cooler in summer.

the base rate of income payments like JobSeeker Payment, Austudy and Youth Allowance payments for eligible people.

This will support close to 8000 people in Cunningham to benefit by \$40 per fortnight. ✓ \$300 million to support upgrades to social housing that will save tenants up to onethird of their energy consumption from upgrades each year.

✓ \$310 million in tax relief via the Small Business Energy Incentive, to provide businesses with annual turnover of less than \$50 million with an additional 20 per cent deduction on spending that supports electrification and more efficient use of energy.

The Government's *Energy Future Plan* will reduce pressure on power bills and cut emissions and supports the efforts being made by locals like Saul Griffith and Rewiring Australia who are working on the ground in our community and with the Albanese Government in Canberra, to make electrification a reality regardless of income or postcode.

The Illawarra's world class innovation and expertise were demonstrated by large attendance of Canberra's diplomatic community all of whom were keen to learn, partner, and collaborate with our expertise.

# **Boosting renewable jobs**

The biggest opportunity for the Illawarra and Australia for growth and prosperity is the global shift to clean and renewable energy and this Labor Government is making the biggest ever investment in Australia's energy transformation.

### **AUKUS UPDATE**

### The Government has made clear that no decision has been made on the location of an east coast naval base and it won't be made till late this decade.

All feasible options will be considered – not just the previous government's three identified locations of Brisbane, Newcastle and Port Kembla. The Assistant Minister for Defence, Matt Thistlethwaite MP, has reiterated in his visits to Wollongong that as the Minister responsible for the Defence Estate, Defence had not expressed a preference for any location.

The Albanese Government made a clear undertaking that we will work with industry, the community and stakeholders to implement the recommendations of the recent Defence Strategic Review and that the Illawarra should continue to attract investment in a range of industries that will grow jobs and opportunity for the region – particularly in the renewable energy sector.
